

## **Glossary of Key Terms**

**AFSL (Australian Financial Services Licence)** – A licence issued by ASIC authorizing a firm to provide financial services under Australian law.

**Algorithmic Trading** – The use of coded rules and logic to automate the buying and selling of securities.

**Backtesting** – A process of testing a trading strategy using historical market data to assess performance and risk.

**Client-Controlled Execution** – A structure where the client retains full authority over trading decisions, position sizing, and risk management, even when using algorithmic strategies.

**Drawdown** – The peak-to-trough decline of an investment or portfolio over a given period.

**Execution-Only** – A service where no personal financial advice is given, and all investment decisions are made by the client.

**Jupyter Notebook** – An open-source tool used for writing, testing, and visualizing algorithmic strategies in Python.

**Risk Management** – A set of processes embedded in a strategy or operation to limit potential financial losses.

**Systematic Strategy** – A trading or investment strategy that is based on pre-defined rules and executed consistently without discretionary overrides.
